Madam/Sir,

With reference to writing off of arrears of Central Excise duty, Service Tax and Customs duty, the following instructions are issued in supersession of guidelines communicated vide Circular No. 1059/8/2017-CX dated 26.09.2017, Corrigendum dated 20.10.2017 and Instructions dated 07.03.2018, in exercise of powers under Delegation of Financial Power Rules, 1978 as amended vide SO 3624 dated 14.12.2012.

2. The Committee of Pr. Chief Commissioners/ Chief Commissioners and Principal Commissioners/ Commissioners constituted in the respective Zones, shall exercise the powers as specified in Column-2 below:-

(i) Pr. Chief Commissioner/ Chief Commissioner of Customs and/ or CGST and CX as specified in Annexure A (for dues of CX and ST) and Annexure B (for dues of Customs) to this Circular	
(ii) Committee of Pr. Commissioner/ Commissioner of Customs and/ or CGST and CX as constituted by the respective Pr. Chief Commissioner/ Chief Commissioner of the Zone.	 (a) Full powers for abandonment of irrecoverable amounts of fines and penalties imposed under the Customs Act, 1962, the Central Excise Act, 1944, the Gold Control Act, 1968, and the Finance Act, 1994; and (b) To write-off irrecoverable amounts of Customs or Central Excise Duty or Service Tax up to Rs. 10 lakhs subject to a report to the next higher authority.


