# Subject: - Revision in the import policy of Tur/Pigeon Peas, Moong and Urad - regarding

Madam/Sir,

Reference is invited to Notification dated 15<sup>th</sup> May, 2021 issued vide S.O 1858 (E) by the Department of Commerce (copy attached) on the above subject.

2. Vide the said notification, the import policy for goods falling under HS Code 0713 with item description as Tur/Pigeon Peas (Cajanus Cajan); Moong [Beans of the SPP Vigna Radiata (L.) Wilczek] and Urad [Beans of the SPP Vigna Mungo (L.) Hepper] is revised from "Restricted" to "Free" with immediate effect and for the period upto 31<sup>st</sup> October 2021. Further, import consignments of these items with Bill of Lading issued on or before 31<sup>st</sup> October 2021 shall not be allowed by Customs beyond 30<sup>th</sup> November 2021.

3. Further, the Department of Consumer Affairs has separately advised that all concerned Departments/organizations including Customs shall ensure import of Pulses in a timely and seamless manner. It is also informed that the said imports would be closely monitored.

4. Board desires that all officers in your jurisdiction are immediately sensitised about the above mentioned changes in the import policy and advised to ensure without fail that such imports are expeditiously cleared upon arrival.

5. Difficulties faced, if any, in this regard may be immediately brought to the notice of the Board. Hindi version follows.

S.O. 1858(E).—In exercise of powers conferred by section 3 read with section 5 of the Foreign Trade (Development and Regulation) Act, 1992 (22 of 1992), read with paragraphs 1.02 and 2.01 of the Foreign Trade Policy, 2015-2020, as amended from time to time, the Central Government, in supersession of Notification No.19/2015-20 dated 5th August, 2017; Notification No.22/2015-2020 dated 21st August, 2017; Notification S.O. 1266(E) dated 19th March, 2021; and Notification S.O. 1372(E) dated 26th March, 2021, hereby amends the import policy of the following items of Chapter 7 of ITC (HS), 2017, Schedule – I (Import Policy) with immediate effect and for the period up to 31st October 2021, as under:

 Further, for import of the above-mentioned three items, Bill of Lading should be issued on or before 31st October, 2021 and import of such consignment shall need to be cleared from Customs on or before 30th November, 2021.

3. Effect of the Notification: Import policy for Tur /Pigeon Peas (Cajanus Cajan); Moong [Beans of the SPP Vigna Radiata (L.) Wilczek] and Urad [Beans of the SPP Vigna Mungo (L.) Hepper] is revised from "Restricted" to "Free" with immediate effect and for the period up to 31st October 2021. Further, import consignments of these items with Bill of Lading issued on or before 31st October, 2021 shall not be allowed by Customs beyond 30th November 2021.
