G.S.R.---(E). In exercise of the powers conferred by the proviso sub section (5) of section 211 of the Companies Act (18 of 2013), the Central Government hereby makes the following rules regulating the method of recruitment to the post of Assistant Director (Digital Forensics), Senior Assistant Director (Digital Forensics) and Deputy Director (Digital Forensics) in the Ministry of Corporate Affairs, Serious Fraud Investigation Office, namely-

Short title and commencement-

- I. These rules may be called the Ministry of Corporate Affairs, Serious Fraud Investigation Office, Assistant Director (Digital Forensics), Senior Assistant Director (Digital Forensics) and Deputy Director (Digital Forensics) Recruitment Rules, 2025.
- II. They shall come into force on the date of their publication in the Official Gazette.
- 2. **Application-** These rules shall apply to the posts specified in theColumn (1) of the Schedule-I, Schedule-II & Schedule-III annexed to these rules.
- 3. Number of posts, classification and level in the pay matrix or pay scale. The number of posts, their classification and the level in the pay matrix or pay scale attached thereto shall be as specified in columns (2) to (4) of the Schedules annexed to these rules.
- 4. Method of recruitment, age limit and other qualifications-The method of recruitment to the said posts, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedules.
- 5. Disqualification- No person,-
- a. who has entered into or contracted a marriage with a person having spouse living, or
- b. who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax- Where the Central Government is of the opinion that it is

- necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and in consultation with Union Public Service Commission relax any of the provisions of these rules with respect to any class or categories of persons.
- 7. **Saving-** Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
