The panel has been prepared in accordance with the 'Insolvency Professionals to act as Interim Resolution Professionals, Liquidators, Resolution Professionals and Bankruptcy Trustees (Recommendation) Guidelines, 2026'.

The validity of the panel is from July 1 – December 31, 2026, with key features as under:

- **Total IPE as IPs:** The panel includes 61 Insolvency Professional Entities (IPEs) registered as IPs.
- **Zonal Classification:** Applicable for selection at any Zone/Bench across India.
- **Sectoral Experience:** Experience of IPE as IPs based on identified sectors have been added. It may be noted that the Sectors have been added for the IPE as IPs for ongoing and completed assignments and the sorting has been done only based on ongoing assignments. In cases where the ongoing and completed assignments are zero, the sectors are mentioned as 'NIL'.
- **Sorting Criteria:** The panel of IPs is sorted by the total number of ongoing assignments (IRP, RP, Liquidator, BT), with those having the lowest number of assignments appearing at the top. For IPE as IPs with the same number of such ongoing assignments, sorting is done by their registration number in ascending order. **It may be noted that this criterion has been adopted solely for sorting purposes and does not, in any manner, reflect the seniority, competence, or efficiency of an IP in handling assignments under the Code.**
- **Assignment Breakdown:** The list includes a breakdown of ongoing assignments (as IRP, RP, Liquidator) in CIRP, and RP (Individual Insolvency, & BT) and total number of completed assignments.
